Professional Program Policy

The Professional Program is designed specifically for professionals who would like to distribute ForeverGreen products through business channels. Any professional who wishes to participate in the ForeverGreen Professional program should follow the application process outlined on the ForeverGreen Professional Program application and fax the application along with a copy of their professional license to ForeverGreen at 801-655-5505. ForeverGreen will review the application, and process the initial order if the application is accepted. Professionals accepted into the ForeverGreen Professional Program will be able to purchase products from ForeverGreen directly and enjoy a 25% discount off the wholesale price. The initial order should meet the requirement of 360SG\$ minimum and additional orders will require a minimum of 360SG\$ per order. ForeverGreen reserves all rights to reject any application and has the right to terminate any professional account immediately if any violation of the ForeverGreen Professional Program or the ForeverGreen Policies and Procedures occurs. Product return or exchange is allowed within 30 days after the order has been placed. All return products must be in re-salable condition. Refund will be credited back to the original form of payment minus a 10% restocking fee.

Potential Professionals

The Professional Program is designed to help Professionals who may be interested in marketing ForeverGreen products and integrating them into their business. This Program is designed primarily for professionals who are in related fields and could benefit by making ForeverGreen's products available to their customers or clients. Professional Program Sign up Checklist

- 1). Help Fill out the Professional Application with your professionals in its entirety.
(A copy of which is posted in your Back Office)
- 2). Fill out the order form with the professional. (Initial orders need to be a minimum of 360SG\$ dollars to meet the professional requirements, 360SG\$ dollars minimum for the repeat orders)
- 3). The application, order form and the copy of professional license (business license) need to be faxed to the corporate office to be reviewed for eligibility to participate in the professional program. ForeverGreen Fax # is (801)-655-5505
- 4). Our member relations department will review and determine eligibility by the end of the following business day.
- 5). After approval the application and order form will be inputted by member relations and the account will be activated.
- 6). After the account is activated member relations will notify the professional and the enroller that the account is active.
- 7). Products will be shipped out within 2 business days after the account is activated.
